

School PD National Survey_Prize Draw Terms and Conditions

Amendment

The School PD survey closing date has been extended from 23:45 BST 30th June 2026 to **23:45 BST 31st July 2026**.

The prize draw date has therefore also been amended from 23:45 BST 30th June 2026 to **23:45 BST 31st July 2026**.

The deadline for notifying winners and issuing e-vouchers has been amended from 23:45 BST on 31st August 2026 to **23:45 BST on 30th September 2026**.

All eligible prize draw entries submitted before the original closing date will remain valid and will be included in the prize draw. Participants who complete the survey and choose to enter the prize draw before the revised closing date will also be eligible, provided they meet the eligibility criteria set out in the original terms and conditions.

All other terms and conditions published on 13th April 2026 remain unchanged.

Promoter

1. The promoter of this prize draw is the **National Institute of Teaching** ("NIoT" hereafter).

The NIoT was co-founded by our Founding MATs via the registered company School-Led Development Trust (company number 13429740; Address: Potovens Lane, Outwood, Wakefield, West Yorkshire, WF1 2PF). The NIoT is a registered charity (charity number 1202423) established for the advancement of education, learning and research for the public benefit.

Eligibility

2. The prize draw is open to individuals in roles responsible for leading or shaping CPD in schools or academies who complete and submit the NIoT's survey titled '*Exploring school-level professional development in schools across England*'.
3. The prize draw is open to UK residents aged 18 or over.

Entry and closing date

4. The prize draw is free to enter and no purchase is necessary.

5. To enter, participants must indicate their wish to take part in the prize draw by submitting the prize draw form and providing valid contact details. Entries must be received by **23:45 BST on 31st July 2026**. Entries received after this time will not be valid.
6. Only one entry per person is permitted. Entrants will receive an automatic receipt of their responses upon submission, generated by Microsoft Forms.

Prize, winner selection and announcement

1. **Six** prizes of £50 Waterstones e-vouchers are available. Waterstones is not connected with, or a sponsor of, the draw.
2. One prize draw will take place, where **six** winners will be chosen by a computer-generated random draw, supervised by an independent member of NIoT staff who is not directly involved in the administration of the survey or prize draw. Winners will be notified using the contact details provided at entry, and the e-voucher will be issued by email by **23:45 on 30th September 2026**.
3. If a winner does not respond to the notification email/phone call within 14 calendar days of being contacted, the NIoT reserves the right to withdraw the prize and select an alternative winner.
4. The prize for the winner is non-exchangeable, non-transferable and no cash alternative is offered.
5. The NIoT will publish or make information available confirming that a valid prize draw has taken place. To comply with this obligation, the NIoT will publish the surnames and regions (in terms of Northeast, Northwest, Southwest, South, East and London, and Midlands) of the winners on the NIoT website. Winners will be given an opportunity to object to their details being published online. In such cases, the NIoT will instead provide alternative confirmation of the draw (e.g. six winners were selected and prizes issued on [date]).

Data protection

6. Personal data provided for the purpose of this prize draw will be processed in accordance with the privacy statement for this prize draw. Please see also condition 11 regarding the publication of winners.

General

7. The NIoT accepts no responsibility for entries not successfully completed due to a technical fault, technical malfunction, computer hardware or software failure, satellite, network or server failure of any kind.
8. The NIoT reserves the right to replace the prize with an alternative prize of equal or higher value if circumstances beyond the NIoT's control makes it necessary to do so.

9. The NIoT's decision regarding any aspect of the prize draw is final and binding and no correspondence will be entered into about it.
10. By entering the prize draw, participants are deemed to have accepted and agreed to be bound by these terms and conditions. The NIoT reserves the right to refuse entry or refuse to award the prize to anyone in breach of these terms and conditions.
11. The prize draw is governed by English law and entrants to the prize draw submit to the jurisdiction of the English courts.
12. This prize draw is conducted in accordance with the NIoT's [overarching policies](#), including its [privacy notices](#) and [data protection policy](#).

Privacy statement regarding information collected for the prize draw

This privacy statement explains how we collect and use your personal information if you choose to enter the prize draw after completing the survey titled '*Exploring school-level professional development in schools across England*'.

The National Institute of Teaching (hereafter "NIoT") is the data controller for this prize draw.

What data we collect

We do not collect any personal data as part of the main survey responses. If you choose to enter the prize draw after completing the main survey, we will collect:

- Your full name
- Your contact information – preferred contact methods, email address, mobile/telephone number
- Your region - Northeast, Northwest, Southwest, South, East and London or Midlands

Providing this information is optional and only required if you wish to enter the prize draw.

How we use your data

We will use the personal data you provide **solely** for the purpose of administering the prize draw, including:

- Contacting winners
- Issuing prizes
- Publishing limited winner information (please see Condition 10 of the Terms and Conditions)

By opting in and providing your details, you consent to your data being used for the purposes described above.

Data storage and retention

Personal data collected for the prize draw will be stored **separately** from the main survey responses. This means that prize draw data **cannot** be used to identify individuals in survey responses.

Information collected for the prize draw will be retained only for as long as necessary to administer the draw and issue prizes, after which it will be securely deleted.

We do not, and will not, sell your data to third parties. NIoT will only share your personal data with third parties, if we are required to do so by law.

All data will be stored securely in accordance with the NIoT's [overarching policies](#), including its [privacy notices](#) and [data protection policy](#).
